MISSION

Just Zero partners with communities, advocates, and policy makers across the country to **implement just and equitable solutions** to climate-damaging and toxic production, consumption, and waste disposal practices.

APPROACH

We prioritize a comprehensive, three-pronged approach to shut down dangerous waste facilities and advance the right policy solutions to reduce and divert waste.



Education

We use conversations, written and visual resources, and educational events to spread awareness about Zero Waste initiatives and to push back against dangerous false solutions to our waste crisis.



Policy

We draft legislation, review proposals, work with lawmakers and community leaders to support prominent Zero Waste initiatives, and advocate before regulatory agencies faced with important waste-related decisions.



Community Engagement

We work directly with community groups, grassroots organizations, and coalitions to give them the tools and resources to protect their environment and blaze their own Zero Waste trails.



2025 in Review

A year of progress, shaped by generosity.

In 2025*, the generosity of our supporters brought substantial momentum to the Zero Waste movement. Together, we raised close to \$1.4 million, spoke to more than 30 groups of advocates, community members, and lawmakers across the country, engaged with more than 2.4k social media followers, and published 6 groundbreaking legislative toolkits to help Zero Waste advocates pursue their own policy priorities.

2025 was about expanding our visibility as a leader on Zero Waste, meeting people where they're at through relatable and accessible content, and working closely with partners to support local, state, and national waste policies. All of that was possible because we added a staff attorney to our Policy & Advocacy team. We also created accessible and engaging materials and engaged directly with federal agencies to build better policies.

We've come this far because of the generosity of our supporters. Every day, you motivate us and our work. It's because of you that we've made such progress this year. And we can't wait to see where we go in the year ahead – together.

IMPACT

RELEASED MODEL LEGISLATIVE TOOLKITS

Every state, city, and community is unique – and there's no one-size-fits-all approach to enacting sensible and effective Zero Waste laws. That's why Just Zero developed six model legislative toolkits – to help community members, advocates and lawmakers build bills that will achieve their own Zero Waste goals.

Each toolkit concentrates on a different issue – beverage containers, food waste, greenwashing, packaging waste, single-use plastics, and high-heat facilities – and is customizable to fit the specific needs of any community.

DEMANDED ACTION ON PACKAGING

In 2025, Just Zero successfully fought to ensure that Maine adopted strong Zero Waste rules for the state's new Packaging Reduction and Recycling Program.

We championed new Bottle Bill legislation across the country while pushing the modernization of existing Bottle Bills. And we joined dozens of activists at the U.S. Capitol to demand bold federal action to eliminate single-use plastics.

INFLUENCED NATIONAL WASTE POLICIES

We made big moves at the national level – successfully convincing the Environmental Protection Agency (EPA) to reject a flawed way of calculating recycled content in consumer products – the first-ever federal action against this misleading system.

We also led advocates nationwide in opposing the plastic industry's efforts to include so-called "advanced recycling" in the EPA's Safer Choice program. On top of that, we addressed the National Recycling Congress on the importance of implementing policies, programs, and laws that eliminate needless packaging waste.

EXPOSED CORPORATE AGENDAS

Just Zero published two reports this year. The first, Landfills and Injustice, exposed how a handful of enormously profitable waste companies exert control over the industry to create mega-landfills that target historically marginalized communities as "sacrifice zones."

The second, Greenwashed 2024, is a new, annual report calling out egregious examples of greenwashing from the past year.

HOSTED WASTE-FREE FUTURE SUMMIT


Our inaugural Waste-Free Future Summit, a free, virtual event featuring five sessions over three days, was a big success. Roughly 400 people from around the globe tuned in to hear directly from advocates, environmental journalists and communicators, Just Zero staff members, and plastic pollution advocate, Diane Wilson, the Keynote Speaker.

Throughout each session, experts shared the powerful strategies they use to mobilize efforts around Zero Waste and to push back against toxic production, consumption, and waste disposal practices.

MOBILIZED TO BAN SEWAGE SLUDGE

Across the country, sewage sludge is a major concern and Just Zero has become a leading voice on the issue. This year, we assisted New York residents in blocking a proposal to build a massive sludge incinerator.


We supported efforts in five states to pass legislation that would ban or limit the land application of sludge. And we even launched a national coalition of more than 35 groups united to end the land application of sludge across the country.




National Reach



BY SOURCE




NET ASSETS

2025: \$576,4512024: \$185,819


2025 EXPENSES*
